



OSB Barrier General Warranty Terms

Oriented Strand Board OSB

WARRANTY TERMS

This warranty applies to GlobalBuild NZ OSB Barrier ('OSB Barrier') supplied by GlobalBuild NZ when used in accordance with all GlobalBuild NZ requirements.

This warranty is to be read in conjunction with all relevant and applicable technical documentation published or referenced by GlobalBuild NZ.

Date warranty valid:

5 years from proven date of purchase or dispatch from GlobalBuild NZ whichever is the earlier.

All enquiries relating to this warranty must (in the first instance) be directed to the place of purchase, the supplier or the installer.

GlobalBuild NZ warrants that:

At the time of delivery to the merchant (or site where applicable) the OSB Barrier will:

- be free from freight-related defects
- be free from defects that may have arisen through defective factory workmanship or materials
- conform to the performance characteristics listed on the current OSB Barrier pass™ ('warranted condition')

In the event a breach of the warranty is proven, the following applies:

- GlobalBuild NZ will, at its discretion, supply replacement OSB Barrier without charge or refund the value of the product.
- Other losses or damage caused by a breach of the warranty or failure of the product for any other reason are not covered.
- GlobalBuild NZ obligations under this warranty are limited to the replacement of defective OSB Barrier or the value of the OSB Barrier. The value of the materials will be reduced pro-rata, based on the remaining life of the product (as set by the relevant durability requirements of the NZ Building Code).
- GlobalBuild NZ reserves the right to supply other comparable materials should the warranted materials no longer be supplied by GlobalBuild NZ.

This warranty is subject to the following:

- Receipt of date of purchase of the product.
- Evidence satisfactory to GlobalBuild NZ of failure of the OSB Barrier.
- Receipt of a written claim from the claimant either within 30 days of when the defect would have become reasonably apparent or, if the defect was reasonably apparent prior to installation, then the claim must be made prior to installation.
- The claim must include full details of the alleged defect.
- Evidence satisfactory to GlobalBuild NZ that all maintenance requirements have been carried out.
- The warranty does not cover failure or problems caused by defective use; failure relating to improper design of the project structure; structural failure; settlement; movement of materials to which the product is attached or dependent on; acts of God including but not limited to earthquakes, cyclones, floods or other severe weather conditions; inadequate maintenance; growth of mould, mildew, fungi, bacteria or any organism on any product; or acts or omissions of a third party over whom GlobalBuild NZ has no control.
- The warranty does not cover failure or loss arising from the failure to follow all relevant GlobalBuild NZ advice and requirements.
- Normal wear and tear is excluded from this warranty.
